a) Nature walk - Cllr L Campion

Members agreed to the following improvements, subject to grants being obtained:-

- 1) Enhancement of entrance board at The Hollows i.e. 'supported by Brizlincote Parish Council'
- 2) Additional boards Marsh, Woods, Geological Unconformity themes
- 3) Fingers added to existing posts near to the wishing well and at the top path near the Hub and opposite the Cemetery.. To read e.g. The Robin Pathway/ The Willow Marshland / The Woodland Hub/Squirrel Walk . Permission agreed .
- 4) Additional tree labels
- 5) Boards attached to the railings in the hub, circular seat and curved benches. Railings also to be repainted.

Res 130 It was resolved that a budget up to £7K would be reserved from councils funds and grant applications be submitted for matched funding.

b) East Side Arts Event

Members were happy for the event to proceed subject to local school support.

The event would commence September, with a view to entries returned prior to October half term. Budget etc to be approved at the next meeting. Topic to be linked to Climate Change Issues.

c) Business plan

The document was approved following a few amendments.

Res 131 It was resolved that the document would be adopted. Reference will be made on the Parish Council website that residents can request a copy.

d) Community Orchard

There was a discussion about the area needing further works. The recently planted trees were discussed.

Members agreed that a site visit was required in the first instance to establish what additional works were required.

e) Brizlincote in Bloom

It was noted that the competition needed to be promoted before the closing date 1st July.

b) Climate change SPD draft consultation

"There is no mention in the document about the provision of Electric Vehicle Charging Points for new building housing and commercial premises. There is also no direct mention of the control and reduction of raw sewage discharge into our watercourses".

c) Recycling scheme
