a) Nature Walk

A community orchard sign will be introduced by East Staffordshire Borough Council.

The parish council are still to confirm if the interpretation board can be relocated following recent vandalism. Members were happy to support ESBC's suggestion of creating a memorial copse made up of native trees and located in the wild flower meadow.

c) East Side Arts Event

d) East Side Music Event – 2023

It was suggested that the music event next year would focus on school bands rather than individual performances. Event to take place potentially in March 2023.
