1/001-2023 Election of Chair

Cllr L Campion wished to thank all members for their support during her term of office.

It was resolved, unanimously that Cllr A Mason be appointed as Chair, Brizlincote Parish Council.

2/002-2023 Declaration of acceptance of office

The chairman completed his acceptance of office.

3/003-2023 Apologies for absence

Parish Councillors A Cowan, R Page, and Borough Cllr C Wileman had submitted their apologies for absence.

4/004-2023 Declaration of interest and dispensation requests for members

The clerk confirmed that no declarations or dispensations had been received.

5/005-2023 Election of other positions/Appointments

Vice Chair

It was resolved that Cllr A Cowan be appointed as Vice Chair for the parish council for the next 12 months.

Appointment of Staffing committee - Defer to the next meeting

Working Groups – defer to the next meeting to allow members to consider which working group they would like to join. It was suggested that a Bee Safari group may be useful and whether it would work combining the Planning Matters working group and Climate change working group rather than having two separate working groups.

The Chair requested that the clerk circulates the groups list to everyone to establish what groups they may wish to be part of.

Delegation scheme – The clerk explained that there had been an incident during the year where a response to a planning application was time sensitive and there was not an opportunity to call an extra ordinary meeting.

Implementing a delegation scheme giving the clerk authority to submit a response following consultation with parish councillors would get around this.

Members agree to proceed with the clerks advice.

6/006-2023 Declaration of General Power of Competence

It was resolved that the parish council, having met the conditions of eligibility as defined in the Localism Act 2011 adopts the general power of competence.

7/007-2023 Meetings

The meeting calendar was approved. It was agreed that there will be no meeting in August.

The December meeting date yet to be agreed.

8/008-2023 Minutes of the meeting 20 April 2023.

Cllr S Moss wished to abstain.

Minutes of the meeting were approved as an actual and factual record.

9/008-2023 Public participation – one member of the public was present.

The resident attended to raise a concern in relation to the little piece of footpath from Tower Road to Ashby Road. The style to access to the field is not adequate. It has been damaged and is not suitable. At the other end of the field the style is not perfect also.

Members felt that land ownership was possibly required.

The resident also raised concerns in relation to block drains, in particular around Woods Lane.

The member of the public wished it to be noted that the additional planters were an enhancement of the parish.

The clerk was requested to pass the highways matters onto County Cllr C Wileman.

10/010-2023 Third party reports

There has been some complaints in relation to litter along Grafton Road.

Members were happy that ESBC proceeded with short term CCTV support if possible to assist with possible identified of any members of the public dropping litter.

Officers have been exploring areas where there is overgrowth making areas currently not accessible.

It was noted that the boundary commission changes had caused some confusion and frustration for local residents.

It was suggested that the clerk contact the MP to establish if parish council boundaries will be changing to fall in line with the ward changes.
